
Meet Dr. Jane Lincove

Dr. Jane Lincove is an associate professor in education policy. Her research focuses on the implementation and effects of market-based policy in public education, including teacher compensation, and the equity effects on lowincome families, minorities, and girls.


Dr. Lincove teaches PUBL 604 Statistical Analysis and PUBL 611 Causal Inference in Program Evaluation. Dr. Lincove received her Ph.D from University of Southern California. She is also a research associate with Tulane University with her research interests include identifying obstacles to college access for minority and low-income high school graduates, measuring the equity effects of school choice lotteries, and learning how charter schools influence the supply and quality of public education. Dr. Lincove's forthcoming research involves the Maryland Longitudinal Data Study to gather information about subject placement exams, high school graduates and where students go to college. Dr. Lincove feels at home at UMBC as she grew up in Arlington, VA.

NASPAA Student Simulation

UMBC Public Policy students **Rebecca Postowski** (M.P.P. '19 Environmental Policy), **Erica Peery** and **David Anguish** (M.P.P. '18 Public Management) competed in a global health simulation in D.C. where they used key public policy concepts to address a simulated global pandemic.

The teams played four rounds which included writing policy briefs and sharing results to the "Prime Minister" for a final presentation. Among the other 560 of the NASPAA Student Batten Simulation participants, were students at competition sites in nine U.S. states as well as in China, Colombia, Egypt, Hungary, and South Korea. **Jennifer Smith** (Ph.D. candidate) was the Shinogle research award recipient.

Erin Stauder (Ph.D. candidate) was recently named by the Daily Record to its 2018 listing of top 100 women. Stauder is the Executive Director of the Hearing and Speech Agency.

Laura Mateczun (Ph.D. candidate) wrote a film review on *Hidden Figures* which was published in *The Journal of Health and Human Experience,* in which she stressed the important role of women of color in STEM.
