#### **Biographies**

#### Ms. Kiki Malomo-Paris

Kiki Malomo-Paris is a Public Policy Ph.D. candidate specializing in evaluation and analytical methods. She previously worked as the Public Health and Policy Fellow at the Green & Healthy Homes Initiative after receiving her Masters at the UMBC School of Public Policy. She is currently a graduate research assistant at The Hilltop Institute within the Medicaid Policy Studies team.

#### Dr. Mary L. Cohen

Mary L. Cohen, Ph.D. is an Associate Professor of Music Education at the University of Iowa. She researches music-making and well-being, songwriting, and collaborative communities. In 2009, she founded the Oakdale Prison Community Choir (http://oakdalechoir.lib.uiowa.edu/). She is completing a book with co-author Stuart Paul Duncan titled Freeing Silenced Voices: Music-Making in Prisons. She is collaborating on an international initiative about the role of music in prison, peacebuilding, and abolitionist principles. Her sister, Judy Shinogle, influenced her to take piano lessons, learn to teach group fitness, and earn a Ph.D.: three things in her life that continue to give her great joy. She wrote a song in honor of Judy called "Find the Joy" that the Oakdale Choir sang in May 2013 and a recording of it is available on the choir website under "original works."

#### Dr. Pinka Chatterji

Pinka Chatterji, Ph.D. is an Associate Professor in the Economics Department at the University at Albany, and a Research Associate at the National Bureau of Economic Research. Her research interests include policies related to public and private health insurance, maternal and child health, and health disparities.

#### Dr. Marisa Domino

Marisa Elena Domino, Ph.D. is a professor in the Department of Health Policy and Management in the Gillings School of Global Public Health; she is also director of the Program on Mental Health and Substance Abuse Systems and Services Research at the Cecil G. Sheps Center for Health Services Research. She received her doctoral degree in health economics from Johns

Hopkins University and completed a postdoctoral fellowship in the economics of mental health at Harvard Medical School's Department of Health Care Policy. Dr. Domino's research interests include the economics of mental health, agency relationships among physicians, patients and insurers, the diffusion of new technologies and the public provision of health care and health insurance to low-income populations.

#### **Stephanie Halling**

Stephanie Halling is a Principal Manager for Computer and Statistical Services with the National Cancer Institute at Frederick as well as Vice President at DMS Health Services at BRMi. Stephanie and Judy shared a love of dogs and competed in many dog sporting events together over the years. Judy's pride and joy, her beloved German Shorthair Pointer, Siegfried, now 15+ years old, resides with Stephanie and her family.

#### Dr. Nancy A. Miller

Nancy A. Miller, Ph.D. is Director and Professor in the School of Public Policy and an Affiliate Professor in the Doctoral Program in Gerontology. She received both her M.A. and Ph.D. from the University of Chicago.

Dr. Miller has conducted interdisciplinary health policy research, focusing on disability and aging issues, for over 25 years, first through her work at the Centers for Medicare and Medicaid Services and then as a faculty member in the School of Public Policy, which she joined in 1998. In 2016, she received the Philip G. Weiler Leadership Award in Aging & Public Health and in 2004 she received the University System of Maryland Regents Faculty Award for Excellence in Mentoring.

#### Dr. David Salkever

David Salkever, Ph.D. is Professor Emeritus in the School of Public Policy where he served on the active faculty from 2005 through 2019. He is also Professor Emeritus of Health Policy and Management in the Bloomberg School of Public Health at Johns Hopkins where he served on the active faculty from 1972 through 2005. While at Johns Hopkins, he served as Judy Shinogle's Ph.D. thesis advisor and collaborated with Judy on studies of the economics of work-related disabilities, health insurance, and mental health services.

#### Dr. Judith Shinogle

Judith Ann "Judy" Shinogle, Ph.D. was a former Senior Research Scientist with the Maryland Institute for Policy Analysis and Research and Adjunct Associate Professor of Public Policy, who passed away in May 2012. Judy's work for MIPAR included studies on gambling, childhood obesity, and wellness initiatives. Her published work includes articles on the effects of mental health insurance coverage on employees' disabilities, mental health parity in insurance, economic costs of obesity, and pharmaceutical use among persons with disabilities.
