Meaghan E. George, M.P.P. 2012

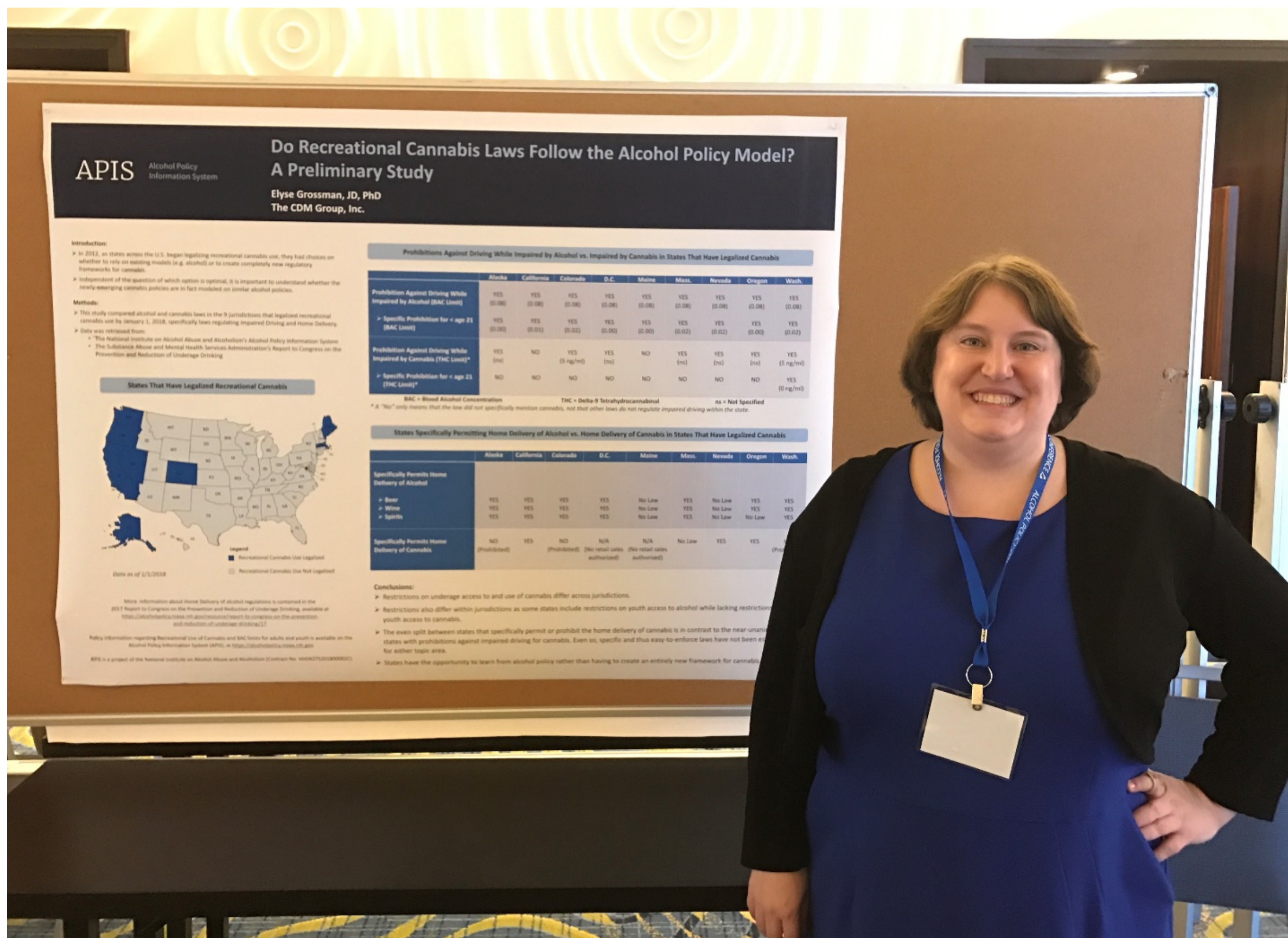
Senior Practice Consultant, CareFirst
